

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Natural Resources Cultural Center &
Museum Freeport McMoRan Budget)

RESOLUTION NO. 17-214

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review**
8 **and approval its FY 2017 Department of Natural Resources Cultural Center &**
9 **Museum Freeport McMoRan Budget, which is incorporated by this reference, in**
10 **the amount of \$68,000.00 to be funded from a donation by Freeport McMoRan**
11 **Foundation; and**

12 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**
13 **the FY 2017 Department of Natural Resources Cultural Center & Museum**
14 **Freeport McMoRan Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2017 Department of Natural Resources Cultural Center & Museum Freeport**
17 **McMoRan Budget in the amount of \$68,000.00, which shall be funded by a**
18 **donation from the Freeport McMoRan Foundation.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
20 **O'odham Nation chairperson or any designated official is authorized to**
21 **administer and expend the FY 2017 Department of Natural Resources Cultural**
22 **Center & Museum Freeport McMoRan Budget, provided that any amendments or**
23 **modifications shall be submitted for prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 31ST**
26 **day of MAY, 2017 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
31 **June 18, 1934 (48 Stat.984).**
