

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Natural Resources Cultural Center &
Museum Budget Amendment No. 1)**

RESOLUTION NO. 17-215

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Natural Resources Cultural Center & Museum Budget**
8 **in the amount of \$1,151,755.54 was approved by Resolution No. 16-322; and**

9 **WHEREAS, the Department of Natural Resources Cultural Center & Museum has received**
10 **Donations and Contributions revenue in the amount of \$2,868.90, and wishes to**
11 **increase its budget accordingly; and**

12 **WHEREAS, the Department of Natural Resources has prepared and submitted for review**
13 **and approval its FY 2017 Department of Natural Resources Cultural Center &**
14 **Museum Budget Amendment No. 1, which is incorporated by this reference and**
15 **which will (1) adjust operational line items; and (2) increase the budget by**
16 **\$2,868.90 from \$1,151,755.54 to \$1,154,624.44 incorporating program donations;**
17 **and**

18 **WHEREAS, the Cultural Preservation and Budget and Finance Committees have reviewed**
19 **the FY 2017 Department of Natural Resources Cultural Center & Museum Budget**
20 **Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2017 Department of Natural Resources Cultural Center & Museum Budget**
23 **Amendment No. 1 which includes a \$2,868.90 increase from \$1,151,755.54 to**
24 **\$1,154,624.44 that shall be funded by program donations.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
26 **O'odham Nation chairperson or any designated official is authorized to**
27 **administer and expend the FY 2017 Department of Natural Resources Cultural**
28 **Center & Museum Budget as amended, provided however, that any amendments**
29 **or modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**
