

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Department of Natural Resources Cultural Affairs Tribal Historic  
Preservation Office Budget Amendment No. 1)**

**RESOLUTION NO. 17-216**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Natural Resources Cultural Affairs Tribal Historic**  
8 **Preservation Office Budget in the amount of \$82,514.00 was approved by**  
9 **Resolution No. 16-430; and**

10 **WHEREAS, the Department of Natural Resources Cultural Affairs Tribal Historic**  
11 **Preservation Office has prepared and submitted for review and approval its FY**  
12 **2017 Budget Amendment No. 1, which is incorporated by this reference and**  
13 **which (1) creates line items 6205 Employer Health, 6215 Employer Dental, and**  
14 **7100 Utilities; and (2) will adjust operational and personnel line items; and**

15 **WHEREAS, the FY 2017 Department of Natural Resources Cultural Affairs Tribal Historic**  
16 **Preservation Office Budget Amendment No. 1 will not change the budget total;**  
17 **and**

18 **WHEREAS, the Cultural Preservation and Budget Finance Committees have reviewed the FY**  
19 **2017 Department of Natural Resources Cultural Affairs Tribal Historic**  
20 **Preservation Office Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2017 Department of Natural Resources Cultural Affairs Tribal Historic**  
23 **Preservation Office Budget Amendment No. 1 in the amount of \$82,514.00 as**  
24 **attached.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
26 **O'odham Nation chairperson or any designated official is authorized to**  
27 **administer and expend the FY 2017 Department of Natural Resources Cultural**  
28 **Affairs Tribal Historic Preservation Office Budget as amended, provided**  
29 **however, that any amendments or modifications shall be submitted for prior**  
30 **approval by the Tohono O'odham Legislative Council.**


