

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Professional Services Agreement Between the Tohono O'odham
Nation and Cinetcomm, LLC)**

RESOLUTION NO. 17-220

1 **WHEREAS, 26 Tohono O'odham Code Chapter 1, Article 4, Section 1402(f) reserves to the**
2 **Legislative Council authority to approve "construction and all other contracts**
3 **and agreements with a total value in excess of \$500,000"; and**

4 **WHEREAS, the Department of Public Safety (DPS) has applied for and was awarded the U. S.**
5 **Department of Justice (DOJ), Office of Community Oriented Policing Service**
6 **(COPS), Tribal Resources Grant Program (TRGP), Award No. 2015HEWX0021,**
7 **which was accepted by TOLC Resolution No. 15-481; and**

8 **WHEREAS, TOLC Resolution No. 17-187 "Approving FY 2017 Department of Public Safety**
9 **Tohono O'odham Nation Police Department 638 Law Enforcement Budget**
10 **Amendment No. 2" allows for the expenditure of funds to purchase satellite**
11 **radio equipment; and**

12 **WHEREAS, TOLC Resolution 15-481 and 17-187 allows for purchase and installation of forty**
13 **eight Satellite Radios including accessories; and**

14 **WHEREAS, after the bidding process, the Department of Public Safety selected Cinetcomm,**
15 **LLC as the vendor to provide and install the Satellite Radios; and**

16 **WHEREAS, the Department of Public Safety has prepared for review and approval a**
17 **Professional Services Agreement between the Tohono O'odham Nation and**
18 **Cinetcomm, LLC in the amount of \$589,638.00; and**

19 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the**
20 **Professional Services Agreement between the Tohono O'odham Nation and**
21 **Cinetcomm, LLC and recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **Professional Services Agreement between the Tohono O'odham Nation and**
24 **Cinetcomm, LLC in substantially the form attached hereto.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairman is authorized to**
26 **execute the Professional Services Agreement between the Tohono O'odham**
27 **Nation and Cinetcomm, LLC providing that any amendments shall be submitted**
28 **for prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 1ST**
30 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 2,789.8 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and 231.6 [05] ABSENT, pursuant to the powers vested in the Council**
32 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
35 **June 18, 1934 (48 Stat.984).**




