

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2017 Executive Office Economic Development Delegation**  
**Budget Amendment No. 1)**

**RESOLUTION NO. 17-221**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Executive Office Economic Development Delegation Budget in the**  
8 **amount of \$2,084,220.00 was approved by Resolution No. 16-322; and**

9 **WHEREAS, the Executive Office has prepared and submitted for review and approval its FY**  
10 **2017 Economic Development Delegation Budget Amendment No. 1, which is**  
11 **incorporated by this reference and will change the name of the budget from**  
12 **"Economic Development Delegation" to "Economic Development Delegation**  
13 **and Gaming Negotiating Committee"; and**

14 **WHEREAS line item 7335 LOBBYING narrative will be amended to include "Lobbying**  
15 **services to support Economic Development Delegation and Gaming Negotiating**  
16 **Committee..."; and**

17 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2017**  
18 **Executive Branch Economic Development Delegation Budget Amendment No. 1**  
19 **and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
21 **the FY 2017 Executive Branch Economic Development Delegation Budget**  
22 **Amendment No. 1, which includes changing the budget name to "Economic**  
23 **Development Delegation and Gaming Negotiating Committee."**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
25 **O'odham Nation Chairperson or any designated official is authorized to**  
26 **administer and expend the FY 2017 Economic Development Delegation and**  
27 **Gaming Negotiating Committee Budget as amended, provided however, that any**  
28 **amendments or modifications shall be submitted for prior approval by the**  
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 1<sup>ST</sup>**  
31 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 2,789.8 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and 231.6 [08] ABSENT, pursuant to the powers vested in the Council**  
33 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
34 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
35 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
36 **Act of June 18, 1934 (48 Stat.984).**




