

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Education, Education Assistance Program
Budget Amendment No. 2)**

RESOLUTION NO. 17-223

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Education, Education Assistance Program Budget in**
8 **the amount of \$5,897,158.81 was approved by Resolution No. 16-322, and**
9 **subsequently amended by Resolution No. 17-028, which included a \$1,522,034.10**
10 **increase; and**

11 **WHEREAS, the Department of Education has prepared and submitted for review and**
12 **approval its FY 2017 Education Assistance Program Budget Amendment No. 2,**
13 **which is incorporated by this reference and which will adjust operational line**
14 **items; and**

15 **WHEREAS, the FY 2017 Department of Education, Education Assistance Program Budget**
16 **Amendment No. 2 will increase the Department of Education FY 2017 Education**
17 **Assistance Program Budget by \$1,913,289.00 from \$7,419,192.91 to \$9,332,481.91;**
18 **and**

19 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
20 **have reviewed the FY 2017 Department of Education, Education Assistance**
21 **Program Budget Amendment No. 2 and recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2017 Department of Education, Education Assistance Program Budget**
24 **Amendment No. 2, which includes a \$1,913,289.00 increase from \$7,419,192.91 to**
25 **\$9,332,481.91 that shall be funded by the General Fund Surplus.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2017 Department of Education, Education Assistance Program**
29 **Budget as amended, provided however, that any amendments or modifications**
30 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**


