

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Legislative Branch Budget Amendment No. 3)**

**RESOLUTION NO. 17-224**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**  
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution**  
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section**  
6 **1(d)(2)); and**

7 **WHEREAS, the FY 2017 Legislative Branch budget was approved by Resolution No. 16-324 and**  
8 **amended by Resolution No. 16-573 for amendment No. 1 and Resolution No. 17-**  
9 **133 for amendment No. 2; and**

10 **WHEREAS, the FY 2017 Legislative Branch Administration has prepared and submitted for**  
11 **review and approval of its budget amendment No. 3, which is incorporated by this**  
12 **reference and which will decrease capital line item and increase operational line**  
13 **items; and**

14 **WHEREAS, the FY 2017 Legislative Branch Budget Amendment No. 3 will not increase the**  
15 **amount of funds originally appropriated to the Legislative Branch; and**


16 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Legislative Branch**  
17 **Budget Amendment No. 3 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2017 Legislative Branch Budget Amendment No. 3, as attached hereto.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council Chairperson and Vice-**  
21 **Chairperson are authorized to administer the FY 2017 Legislative Branch Budget**  
22 **as amended, provided however, that any amendments and modifications**  
23 **affecting these funds or funding levels budgeted shall be submitted for prior**  
24 **approval by the Tohono O'odham Legislative Council .**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 1<sup>ST</sup> day**  
26 **of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST;**  
27 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
28 **Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
29 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
31 **(48 Stat.984).**
