

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Pre-Award and Start-up Budget Amendment No. 1)**

**RESOLUTION NO. 17-230**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Health and Human Services Pre-Award and Start-up budget was**  
8 **approved by Resolution No. 17-015 in the amount of \$609,127.80; and**

9 **WHEREAS, the FY 2017 Health and Human Services Pre-award and Start-up Budget**  
10 **Amendment No. 1 which will (1) increase the Direct Cost Reimbursement by**  
11 **\$3,962,149.53; and (2) increase the Indirect cost by \$329,483.43 for a total**  
12 **increase of \$4,291,632.96 increasing the overall budget from \$609,127.80 to**  
13 **\$4,900,760.76; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**  
15 **Legislative Council have reviewed the FY 2017 Health and Human Services Pre-**  
16 **award and Start-up Budget Amendment No. 1 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2017 Pre-award and Start-up Amendment No. 1 increasing the budget by**  
19 **\$4,291,632.96 including an increase to the Direct and Indirect Cost for a new**  
20 **total of \$4,900,760.76 to be funded by Self Governance funds.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
22 **O'odham Nation Chairperson or any designated official is authorized to**  
23 **administer and expend the 2017 Health and Human Services Pre-award and**  
24 **Start-up Budget provided, that the Governing Body shall approve any**  
25 **amendments or modifications, subject to final approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
28 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**
