RESOLUTION NO. 17-243

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article II,**
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
6 **Enrollment Committee is responsible for reviewing enrollment applications**
7 **and making recommendations to the Legislative Council regarding the**
8 **eligibility of applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1);**
9 **and**

10 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**
11 **O'odham Legislative Council shall determine whether an application is**
12 **approved for membership and its determination, along with the resolution**
13 **number and date of enactment, shall be provided to the applicant; and**

14 **WHEREAS, the Enrollment Program has determined that a number of resolutions**
15 **approving membership and adoption applications misspelled or incorrectly**
16 **listed the names of members and/or incorrectly listed enrollment numbers; and**

17 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 86-82, 127-**
18 **83, 102-84, 98-174, 99-311, 99-360, 99-475, 99-561, 2000-003, 2000-035, 2000-083,**
19 **01-496, 01-589, 03-463, 07-236, 10-020, 16-217, 17-122, and 17-003 be amended to**
20 **reflect the correct name and/or enrollment number for the members identified**
21 **in the June 2017 Corrected Enrollment Resolution Summary, which is**
22 **incorporated by this reference.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
24 **Resolution Nos. 86-82, 127-83, 102-84, 98-174, 99-311, 99-360, 99-475, 99-561,**
25 **2000-003, 2000-035, 2000-083, 01-496, 01-589, 03-463, 07-236, 10-020, 16-217, 17-**
26 **122, and 17-003 are amended upon the effective date of those resolutions to**
27 **reflect the correct name and/or enrollment number for the members identified**
28 **in the June 2017 Corrected Enrollment Resolution Summary.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
30 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
32 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**
33 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**
34 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
35 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
