

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Certification of Tohono O'odham Nation Eligible Adult Members  
for the Third Per Capita Distribution for June 2017)**

**RESOLUTION NO. 17-248**

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the**  
2 **"O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes**  
3 **per capita payments to the Nation's members provided that sufficient gaming**  
4 **revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities Within the Tohono**  
6 **O'odham Nation (the "Gaming Ordinance") was subsequently amended to**  
7 **authorize per capita distribution payments in accordance with the Initiative**  
8 **(Legislative Council Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Third Revenue Allocation Plan and pursuant**  
10 **to Legislative Council Resolution No. 06-307; and**

11 **WHEREAS, on July 28, 2006, the Secretary of the Department of Interior approved the Third**  
12 **Revenue Allocation Plan; and**

13 **WHEREAS, the Tohono O'odham Nation Department of Membership Services submitted to**  
14 **the Tohono O'odham Legislative Council the Master List for Eligible Adult Tohono**  
15 **O'odham Members for the Third Per Capita Distribution ("Master List") for review**  
16 **and approval; and**

17 **WHEREAS, Legislative Council approved the Master List with the initial number of 17,669**  
18 **verified adult members (Resolution Number 06-624); and**

19 **WHEREAS, the disbursement of funds to each eligible adult member is contingent upon**  
20 **verification of a member and certification by the Tohono O'odham Legislative**  
21 **Council; and**

22 **WHEREAS, the Tohono O'odham Department of Membership Services has submitted a**  
23 **certification list of two verified adult members who are listed on the previously**  
24 **approved Master List and are eligible to receive the third per capita payment.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 26 **1. Approves the verification and certification of two adult members listed on**  
27 **the attached June 2017 Certification Listing of Adult Members for the Third**  
28 **Per Capita Distribution.**
- 29 **2. Approves the distribution of \$2,000, less any applicable taxes required by**  
30 **federal law, to each adult member listed.**
- 31 **3. Authorizes the Chairperson of the Nation or a designated official to**  
32 **execute such other documents as may be necessary to implement this**  
33 **resolution.**


