

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Adult Protective
Services Division Elder Abuse Prevention Budget)

RESOLUTION NO. 17-251

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Adult Protective Services Division**
8 **has prepared and submitted for review and approval its FY 2017 Elder Abuse**
9 **Prevention Budget, which is incorporated by this reference, in the amount of**
10 **\$118,321.10 to be funded by the Administration for Community**
11 **Living/Administration on Aging; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2017 Department of Health and Human Services Adult Protective**
14 **Services Division Elder Abuse Prevention Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2017 Department of Health and Human Services Adult Protective Services**
17 **Division Elder Abuse Prevention Budget in the amount of \$118,321.10 which shall**
18 **be funded via reimbursement by the Administration for Community**
19 **Living/Administration on Aging.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2017 Department of Health and Human Services Adult Protective**
23 **Services Division Elder Abuse Prevention Budget, provided that any amendments**
24 **or modifications shall be submitted for prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
27 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
