

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting
Community Service Grant Restricted Budget)**

RESOLUTION NO. 17-252

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2017**
8 **Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community Service**
9 **Grant Restricted Budget, which is incorporated by this reference, in the amount**
10 **of \$55,855.41 to be funded by allocating \$9,024.76 in indirect administrative**
11 **support as required by Resolution No. 16-359 and \$46,830.65 from the FY 2017**
12 **Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community Service**
13 **Grant Budget also approved by Resolution No. 16-359; and**

14 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**
15 **the FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community**
16 **Service Grant Restricted Budget and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2017 Hewel Ni'ok's KOHN Corporation for Public Broadcasting Community**
19 **Service Grant Restricted Budget in the amount of \$55,855.41 effective October 1,**
20 **2016, of which \$46,830.65 that shall be funded via reimbursement from the**
21 **grantor and \$9,024.76 is recorded as indirect administrative support.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer**
24 **including following any cash management requirements from the funding**
25 **agency and expend the FY 2017 Hewel Ni'ok's KOHN Corporation for Public**
26 **Broadcasting Community Service Grant Restricted Budget as approved, provided**
27 **however, that any amendments or modifications shall be submitted for prior**
28 **approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
30 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
