

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting 2017 - 2019 Legislative Council Committee Meeting Schedule)**

LEGISLATIVE ORDER NO. 17-253

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish**
2 **rules and procedures to regulate all meetings of the . . . standing committees"**
3 **(Constitution, Article VI, Section 1(a)); and**

4 **WHEREAS, "the legislative committees of the Legislative Council are the standing**
5 **committees of the Legislative Branch performing continuing functions for an**
6 **indefinite time, whose membership shall consist of representatives to the**
7 **Legislative Council." (Legislative Rules of the Tohono O'odham Legislative**
8 **Council, Article XI, Section 1(A)(1)); and**

9 **WHEREAS, on June 16, 2017, following the election of the Chairperson and Vice-**
10 **Chairperson, the Tohono O'odham Legislative Council elected committee**
11 **members and officers to the Council's 12 standing committees; and**

12 **WHEREAS, the Legislative Rules Committee has drafted a schedule listing regular**
13 **Legislative Council committee meetings for 2017-2019 which is dated for**
14 **reference June 19, 2017.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it adopts**
16 **the "2017-2019 Legislative Council Committee Meeting Schedule" which shall**
17 **remain in effect until committee memberships are elected following the**
18 **Nation's 2019 general election.**

19 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 19TH day of**
20 **JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
23 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
25 **June 18, 1934 (48 Stat.984).**
