

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services HIV/AIDS
Budget Amendment No. 1)**

RESOLUTION NO. 17-254

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Health and Human Services ("DHHS") HIV/AIDS**
8 **Budget in the total amount of \$238,211.00 was approved by Resolution No. 16-327;**
9 **and**

10 **WHEREAS, the DHHS HIV/AIDS Program has prepared and submitted for review and**
11 **approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**
12 **reference and which will (1) adjust operational line items; and (2) adjust indirect**
13 **cost charges; and**

14 **WHEREAS, the FY 2017 DHHS HIV/AIDS Budget Amendment No. 1, will not change the base**
15 **budget amount; and**

16 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
17 **reviewed the FY 2017 DHHS HIV/AIDS Budget Amendment No. 1 and recommend**
18 **its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 Department of Health and Human Services HIV/AIDS Budget Amendment**
21 **No. 1 as attached which will adjust operational line items and the indirect cost**
22 **charges with no change to the overall budgeted amount.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the chairperson or**
24 **any designated official is authorized to administer and expend the FY 2017 DHHS**
25 **HIV/AIDS Budget as amended, provided however, that any amendments or**
26 **modifications shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
29 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
