

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Women,
Infants and Children-ITCA Budget Amendment No. 1)

RESOLUTION NO. 17-255

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2017 Department of Health and Human Services Women, Infants and
8 Children (WIC)-Inter-Tribal Council of Arizona (ITCA) Budget in the amount of
9 **\$182,200.00** was approved by Resolution No. 16-336; and

10 **WHEREAS,** the WIC-ITCA Program has received an award increase of **\$5,040.00**; and

11 **WHEREAS,** the WIC- ITCA Program has prepared and submitted for review and approval its
12 FY 2017 Department of Health and Human Services Women, Infants and
13 Children-ITCA Budget Amendment No. 1, which is incorporated by this reference
14 and which will adjust operational line items and adjust indirect cost charges; and

15 **WHEREAS,** the FY 2017 WIC-ITCA Budget Amendment No. 1 will increase the budget by
16 **\$5,040.00** from **\$182,200.00** to **\$187,240.00**; and

17 **WHEREAS,** the Health and Human Services and the Budget and Finance Committees have
18 reviewed the FY 2017 WIC-ITCA Budget Amendment No. 1 and recommend its
19 approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 FY 2017 Department of Health and Human Services Women, Infants and
22 Children-ITCA Budget Amendment No. 1 which includes a **\$5,040.00** increase
23 from **\$182,200.00** to **\$187,240.00** that shall be funded via reimbursement by the
24 Inter-Tribal Council of Arizona, Inc.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
26 Nation chairperson or any designated official is authorized to administer and
27 expend the FY 2017 WIC-ITCA Budget as amended, provided however, that any
28 amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.
