

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Senior Services
Division Title VI Medicare Improvement for Patient and Providers Act Budget)**

RESOLUTION NO. 17-257

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services Senior Services Division has
8 prepared and submitted its FY 2017 Title VI Medicare Improvement for Patient
9 and Providers Act ("MIPPA") Budget, which is incorporated by this reference, in
10 the amount of \$5,090.00 to be funded from the U.S. Department of Health and
11 Human Services Administration for Community Living for a period beginning
12 September 30, 2016 to September 29, 2017; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the Department of Health and Human Services Senior Services Division
15 Title VI MIPPA Budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 **FY 2017 Department of Health and Human Services Senior Services Division Title**
18 **VI Medicare Improvement for Patient and Providers Act Budget in the total**
19 **amount of \$5,090.00 to become effective upon the date of this resolution to**
20 **September 29, 2017, which shall be funded via reimbursement by the U.S.**
21 **Department of Health and Human Services Administration for Community**
22 **Living.**

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2017 Department of Health and Human Services Senior Services**
26 **Division Title VI MIPPA Budget, provided that any amendments or modifications**
27 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**
29 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
