

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Tohono O'odham Nation Veterans Affairs Office Budget Amendment No. 1)

RESOLUTION NO. 17-260

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Veterans Affairs Office Budget in the amount of \$120,637.53 was**
8 **approved by Resolution No. 16-322; and**

9 **WHEREAS, the Veterans Affairs Office has received Revenue Donations, pursuant to**
10 **Resolution No. 16-034, and wishes to increase its budget accordingly; and**

11 **WHEREAS, the Veterans Affairs Office has prepared and submitted for review and approval**
12 **its FY 2017 Budget Amendment No.1, which is incorporated by this reference;**
13 **which will (1) adjust operational line items; and (2) increase the FY 2017**
14 **Veterans Affairs Office Budget by \$3,408.00 from \$120,637.53 to \$124,045.53 that**
15 **shall be funded by Revenue Donations; and**

16 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
17 **have reviewed the FY 2017 Veterans Affairs Office Budget Amendment No. 1 and**
18 **recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 Veterans Affairs Office Budget Amendment No. 1, which includes a**
21 **\$3,408.00 increase from \$120,637.53 to \$124,045.53 that shall be funded by**
22 **Revenue Donations.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
24 **O'odham Nation chairperson or any designated official is authorized to**
25 **administer and expend the FY 2017 Veterans Affairs Office Budget as amended,**
26 **provided however, that any amendments or modifications shall be submitted**
27 **for further prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
29 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**
