

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Tohono O'odham Nation Department of Health and Human Services
Special Needs Division First Things First-Child Support Budget)

RESOLUTION NO. 17-261

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Special Needs Division has**
8 **prepared and submitted for review and approval its FY 2018 First Things First-**
9 **Child Support Budget, which is incorporated by this reference, in the amount of**
10 **\$225,000.00 to be funded from the Arizona Early Childhood Development and**
11 **Health Board; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
13 **reviewed the FY 2018 Department of Health and Human Services Special Needs**
14 **Division First Things First-Child Support Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2018 Department of Health and Human Services Special Needs Division First**
17 **Things First-Child Support Budget effective July 1, 2017 in the amount of**
18 **\$225,000.00, which shall be funded by the Arizona Early Childhood Development**
19 **and Health Board and authorizes the use the Nation's resources pending**
20 **reimbursement from the grantor.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2018 Department of Health and Human Services**
24 **Special Needs Division First Things First-Child Support Budget, provided that**
25 **any amendments or modifications shall be submitted for prior approval by the**
26 **Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
28 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
