(Setting June 29, 2017 Special Session to Review Tohono O'odham Nation's FY 2016  
Basic Financial Statements and Independent Auditors' Report)**

**LEGISLATIVE ORDER NO. 17-263**


1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6 **Council with the authority to "by majority vote, call for a special session"**  
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8 **1.D.1.); and**

9 **WHEREAS, the Budget and Finance Committee has requested a special session on June 29,**  
10 **2017 to review the Tohono O'odham Nation's FY 2016 Basic Financial Statements**  
11 **and Independent Auditors' Report.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
13 **special session on June 29, 2017 to review the Tohono O'odham Nation's FY 2016**  
14 **Basic Financial Statements and Independent Auditors' Report; provided that no**  
15 **other agenda items will be added to the June 29, 2017 special session.**

16 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 23<sup>RD</sup> day of**  
17 **JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
19 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
22 **June 18, 1934 (48 Stat.984).**
