

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 5 to the Intergovernmental Agreement #ADES14-053077
Between the Arizona Department of Economic Security and the Tohono O'odham
Nation for the Planned Social Services Block Grant Title XX Program)**

RESOLUTION NO. 17-264

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority to "promote, protect and provide for public health, peace,**
3 **morals, education and general welfare of the Tohono O'odham Nation and its**
4 **members" and to "consult, negotiate and conclude agreements and contracts on**
5 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
6 **and other Indian tribes or their departments . . ." (Constitution, Article VI,**
7 **Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**
9 **affordability and quality of child care through funding provided by the Arizona**
10 **Department of Economic Security ("AZDES") Planned Social Services Block Grant**
11 **Title XX Program; and**

12 **WHEREAS, the Tohono O'odham Nation has entered into a cost-reimbursement**
13 **Intergovernmental Agreement ("IGA") with ADES for Planned Social Services**
14 **Block Grant Title XX Program pursuant to Resolution No. 13-256, Contract**
15 **#ADES14-053077; and**

16 **WHEREAS, Amendment No. 5 amends the IGA to provide that for the period of July 1, 2017,**
17 **through June 30, 2018, the contract reimbursement ceiling is \$99,612.00; and**

18 **WHEREAS, the Itemized Service Budget for the period of July 1, 2017, through June 30, 2018,**
19 **is attached and added to the Agreement; and**

20 **WHEREAS, the Human Resources Development Committee of the Tohono O'odham**
21 **Legislative Council has reviewed the Amendment and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
23 **Amendment No. 5 to the Intergovernmental Agreement between the Arizona**
24 **Department of Economic Security and the Tohono O'odham Nation for the**
25 **Planned Social Services Block Grant Title XX Program, Contract #ADES14-**
26 **053077 in substantially the form attached and authorizes the Chairman to**
27 **execute it.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
29 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)and(f) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**




