

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 San Lucy District Diabetes Program Budget)**

RESOLUTION NO. 17-274

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation:**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council; and**

11 **WHEREAS,** by Resolution No. SL 06-96-17, the San Lucy District Council approved the FY
12 **2017 San Lucy District Diabetes Program Budget in the amount of \$40,872.98 for**
13 **the period of June 1, 2017 through September 30, 2017; and**

14 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2017 San Lucy District
15 **Diabetes Program Budget which is incorporated by this reference and**
16 **recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 **FY 2017 San Lucy District Diabetes Program Budget in the amount of \$40,872.98**
19 **for the period of June 1, 2017 through September 30, 2017 that shall be funded**
20 **from San Lucy District gaming revenues.**

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2017 San Lucy
22 **District Diabetes Program Budget shall be managed and expended in**
23 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
24 **Nation and the Nation's laws, provided that any amendments or modifications**
25 **shall be authorized under District Council resolution and submitted for prior**
26 **approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD**
28 **day of JUNE, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
30 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
