

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Enrollment Resolution No. 17-169, "Approving Enrollment or Adoption
Applications for Membership in the Tohono O'odham Nation for May 2017,"
to Delete Member who was Approved Twice)**

RESOLUTION NO. 17-283

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members (Article VI,**
3 **Section 1 (h) of the Constitution of the Tohono O'odham Nation); and**
4 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**
5 **Enrollment Committee is responsible for reviewing enrollment applications and**
6 **making recommendations to the Legislative Council regarding the eligibility of**
7 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**
8 **WHEREAS, the Enrollment Program has determined that a member was originally approved**
9 **for membership by Resolution No. 13-331; and**
10 **WHEREAS, the Enrollment Program discovered that this same member was mistakenly**
11 **approved a second time for membership by Resolution No. 17-169; and**
12 **WHEREAS, the Enrollment Program therefore recommends that Resolution No. 17-169 be**
13 **amended to delete the member identified in the attached Amending Enrollment**
14 **Resolution List July 2017; and**
15 **WHEREAS, the member that was originally approved in Resolution No. 13-331 will retain the**
16 **roll number and approval date identified in that resolution.**
17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
18 **No. 17-169, Approving Enrollment or Adoption Applications for Membership in**
19 **the Tohono O'odham Nation for May 2017," is amended upon effective date of that**
20 **resolution by deleting the member and corresponding information identified in**
21 **the attached Amending Enrollment Resolution List July 2017.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10th**
23 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**
26 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
28 **16 of the Act of June 18, 1934 (48 Stat.984).**
