

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 General Support Services, Accounting Department  
Budget Amendment No. 1)**

**RESOLUTION NO. 17-294**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 General Support Services ("GSS"), Accounting Department Budget in**  
8 **the amount of \$3,402,562.81 was approved by Resolution No. 16-322; and**

9 **WHEREAS, the FY 2017 GSS Accounting Department Supplemental Budget was approved by**  
10 **Resolution No. 16-525 in the amount of \$1,627,468.97 for a combined FY 2017 GSS**  
11 **Accounting Department Budget total of \$5,030,031.78; and**

12 **WHEREAS, the GSS Accounting Department prepared and submitted for review and**  
13 **approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**  
14 **reference, and which will adjust operational and personnel line items; and**

15 **WHEREAS, the FY 2017 GSS Accounting Department Budget Amendment No. 1 will not**  
16 **change the total amount of the base budget; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees reviewed**  
18 **the FY 2017 GSS Accounting Department Budget Amendment No. 1 and**  
19 **recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2017 GSS Accounting Department Budget Amendment No. 1.**


22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
23 **O'odham Nation chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2017 GSS Accounting Department Budget as**  
25 **amended, provided however, that any amendments or modifications shall be**  
26 **submitted to the Tohono O'odham Legislative Council for prior approval.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
28 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**






