

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services Division of Community Health Services CH Third Party Revenue Budget)

RESOLUTION NO. 17-296

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services ("DHHS") Division of Community**
8 **Health Services has prepared and submitted for review and approval its FY 2017**
9 **CH Third Party Revenue Budget, which is incorporated by this reference, in the**
10 **amount of \$20,000.00 to be funded from the State of Arizona Health Care Cost**
11 **Containment Systems ("AHCCCS") collections; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees have**
13 **reviewed the FY 2017 CH Third Party Revenue Budget and recommend its**
14 **approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **the FY 2017 DHHS Division of Community Health Services CH Third Party**
17 **Revenue Budget in the amount of \$20,000.00, which shall be funded by AHCCCS**
18 **collections and authorizes any unspent Community Health Third Party Billing**
19 **revenue be made available for reappropriation for the Division of Community**
20 **Health Services in future fiscal years.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 DHHS Division of Community Health**
24 **Services CH Third Party Revenue budget, provided that any amendments or**
25 **modifications shall be submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
28 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**






