

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 the Executive Office of the Chairman's Budget Amendment No. 1)

RESOLUTION NO. 17-297

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Executive Office of the Chairman's Budget in the amount of**
8 **\$1,209,689.14 was approved by Resolution No. 16-322; and**

9 **WHEREAS, the Executive Office of the Chairman has prepared and submitted for review and**
10 **approval its FY 2017 Executive Office of the Chairman's Budget Amendment No.**
11 **1, which is incorporated by this reference and which (1) will adjust operational**
12 **line items; (2) add new line items 6725 Awards-Employees, 7500 Major Capital;**
13 **and (3) will increase the Executive Office of the Chairman's Budget by \$41,000.00**
14 **from \$1,209,689.14 to \$1,250,689.14; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Executive Office of**
16 **the Chairman's Budget Amendment No. 1 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2017 Executive Office of the Chairman's Budget Amendment No. 1 effective**
19 **October 1, 2016, which includes a \$41,000.00 increase from \$1,209,689.14 to**
20 **\$1,250,689.14 that shall be funded by the General Fund Surplus; and**


21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
22 **O'odham Nation chairperson or any designated official is authorized to**
23 **administer and expend the FY 2017 Executive Office of the Chairman's Budget as**
24 **amended, provided however, that any amendments or modifications shall be**
25 **submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
27 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 1,785.8 FOR;**
28 **1,063.0 AGAINST; 235.8[01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
29 **Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**
30 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
31 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
32 **16 of the Act of June 18, 1934 (48 Stat.984).**


