

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Public Safety Environmental Protection Office
Brownfields Program Budget Amendment No. 1)**

RESOLUTION NO. 17-299

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "all expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Public Safety Environmental Protection Office**
8 **("EPO") Brownfields Program Budget in the amount of \$150,000.00 was approved**
9 **by Resolution No. 16-353; and**

10 **WHEREAS, the Department of Public Safety EPO has prepared and submitted for review and**
11 **approval its FY 2017 Budget Amendment No. 1, which is incorporated by this**
12 **reference and which will adjust personnel and/or operational line items; and**

13 **WHEREAS, the FY 2017 Department of Public Safety EPO Brownfields Program Budget**
14 **Amendment No. 1 will increase the Department of Public Safety EPO FY 2017**
15 **Brownfields Program Budget by \$10,000.00 from \$150,000.00 to \$160,000.00; and**

16 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
17 **2017 Department of Public Safety EPO Brownfields Program Budget Amendment**
18 **No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2017 Department of Public Safety EPO Brownfields Program Budget**
21 **Amendment No. 1, which includes an increase of \$10,000.00 from \$150,000.00 to**
22 **\$160,000.00 that shall be funded by the United States Environmental Protection**
23 **Agency Assistant Agreement Grant under the Brownfields 128(a) Tribal Response**
24 **Program.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
26 **O'odham Nation chairperson or any designated official is authorized to**
27 **administer and expend the FY 2017 Department of Public Safety EPO**
28 **Brownfields Program Budget as amended, provided however, that any**
29 **amendments or modifications shall be submitted for prior approval by the**
30 **Tohono O'odham Legislative Council.**
