

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Vamori Community Budget Amendment No. 2)

RESOLUTION NO. 17-300

1 **WHEREAS, Pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation, "No District shall expend district funds except pursuant to budgets**
3 **authorized under resolutions of the district council and approved by the Tohono**
4 **O'odham Council. The management of these funds shall be only by a treasurer**
5 **or other authorized officer of the district council who has furnished a surety**
6 **bond satisfactory to the treasurer of the Tohono O'odham Nation and all**
7 **expenditures of these funds shall be by checks signed by such treasurer or other**
8 **authorized officer and the chairman or vice chairman of the district council";**
9 **and**

10 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 16-465**
11 **Approving FY 2017 Chukut Kuk District Budgets; and**

12 **WHEREAS, Vamori Community FY2017 Budget Amendment No. 1 was approved by**
13 **Legislative Council Resolution No. 17-212; and**

14 **WHEREAS, the Vamori Community has submitted for review and approval the FY 2017**
15 **Budget Amendment to carry over FY 2010 Surplus Funds incorporated by this**
16 **reference which increases line item and adds language to the budget**
17 **justification to item 725-Well Supplies; and**

18 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Vamori**
19 **Community Budget Amendment No. 2 and recommends its approval.**


20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
21 **approves the FY 2017 Vamori Community Budget Amendment No. 2 to carryover**
22 **\$4,310.00 from FY 2010 Surplus Funds increasing the overall budget from**
23 **\$72,924.36 to \$77,234.36.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **District Chairperson and any designated official to expend and administer the**
26 **FY 2017 Vamori Community budget provided that any modifications or**
27 **amendments shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
30 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
32 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


