

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Hewel Ni'ok KOHN Corporation for Public Broadcasting
Community Service Grant Budget Amendment No. 2)**

RESOLUTION NO. 17-301

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the FY 2017 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
8 Service Grant Budget in the amount of \$272,585.47 was approved by Resolution
9 No. 16-359; and

10 **WHEREAS,** the FY 2017 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
11 Service Grant Budget Amendment No. 1 was approved by Resolution No. 17-102
12 which decreased the Hewel Ni'ok FY 2017 KOHN Corporation for Public
13 Broadcasting Community Service Grant Budget by \$77,478.01 from \$272,585.47
14 to \$195,107.46 segregating the restricted and unrestricted portions of the grant;
15 and

16 **WHEREAS,** Hewel Ni'ok has prepared and submitted for review and approval its FY 2017
17 Budget Amendment No. 2, which is incorporated by this reference and which will
18 adjust operational line items by carrying forward the unobligated balance of
19 fiscal year 2016; and

20 **WHEREAS,** the FY 2017 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
21 Service Grant Budget Amendment No. 2 will increase the FY2017 Hewel Ni'ok
22 KOHN Corporation for Public Broadcasting Community Service Grant Budget as
23 amended by \$14,055.00 from \$195,107.46 to \$209,162.46; and

24 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed
25 the FY 2017 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
26 Service Grant Budget Amendment No. 2 and recommend its approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2017 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
29 Service Grant Budget Amendment No. 2, effective October 1, 2016, which
30 includes a \$14,055.00 increase from \$195,107.46 to \$209,162.46 that shall be
31 funded by carrying forward the unobligated balance of fiscal year 2016.

32 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
33 O'odham Nation chairperson or any designated official is authorized to
34 administer and expend the FY 2017 Hewel Ni'ok KOHN Corporation for Public

Broadcasting Community Service Grant Budget as amended, provided however, that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11th day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


