

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Chester L. Antone to the National Institutes of Health
Tribal Consultation Advisory Committee as Area Representative and Representative
Daniel L.A. Preston, III as Alternate)**

RESOLUTION NO. 17-304

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**
2 **protect and provide for public health . . . and general welfare of the Tohono**
3 **O'odham Nation and its members" and with the authority "to consult with the**
4 **Congress of the United States and appropriate federal agencies regarding federal**
5 **activities that affect the Tohono O'odham Nation" (Constitution, Article VI,**
6 **Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, the National Institutes of Health ("NIH") established the Tribal Consultation**
8 **Advisory Committee ("TCAC") as an important step towards improving**
9 **consultation efforts and outreach with tribal partners; and**

10 **WHEREAS, the NIH TCAC serves as an advisory body to NIH, helping to ensure that tribes and**
11 **American Indian/Alaska Native people have meaningful and timely input in the**
12 **development of relevant NIH policies, programs, and priorities; and**

13 **WHEREAS, the NIH TCAC membership includes elected officials or a tribal employee**
14 **designated to act on behalf of a tribal leader nominated by the area director from**
15 **each of the 12 geographic areas served by the Indian Health Service and five**
16 **national at-large representatives; and**

17 **WHEREAS, the Health and Human Services Committee recommends nominating**
18 **Representative Chester L. Antone to the NIH TCAC as the Tucson Area**
19 **representative and Representative Daniel L.A. Preston, III as alternate to**
20 **Representative Chester L. Antone.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council that it**
22 **nominates Representative Chester L. Antone to the National Institutes of Health**
23 **Tribal Consultation Advisory Committee as the Tucson Area representative and**
24 **Representative Daniel L.A. Preston, III as alternate to Representative Chester L.**
25 **Antone.**

26 **BE IT FINALLY RESOLVED that any subsequent appointments made pursuant to this resolution**
27 **shall supersede any prior nominations and appointments to the Tribal**
28 **Consultation Advisory Committee and shall immediately expire if the appointed**
29 **representatives no longer serve for any reason as members of the Health and**
30 **Human Services Committee.**






