

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Adrienne Tiller as Primary Representative to the
Indian Health Service National Tribal Advisory Committee on Behavioral
Health and Representative Anthony J. Francisco, Jr. as Alternate)**

RESOLUTION NO. 17-305

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power "to promote,
2 protect and provide for public health . . . and general welfare of the Tohono
3 O'odham Nation and its members" and with the authority "to consult with the
4 Congress of the United States and appropriate federal agencies regarding federal
5 activities that affect the Tohono O'odham Nation" (Constitution, Article VI,
6 Section 1(c)(2) and Section 1(j)); and

7 **WHEREAS,** the Indian Health Service established the National Tribal Advisory Committee on
8 Behavioral Health ("NTAC") to enhance the government-to-government
9 relationship and the Division of Behavioral Health's efforts to improve service
10 delivery within Indian Country (NTAC Mission Statement); and

11 **WHEREAS,** the "NTAC helps guide the development of, and support for, behavioral health
12 throughout the IHS/Tribal/Urban (ITU) systems, and work to ensure that services
13 are as broadly integrated, available and culturally appropriate as possible"
14 (National Tribal Advisory Committee on Behavioral Health webpage, available at
15 <https://www.ihs.gov/dbh/ntac/>); and

16 **WHEREAS,** NTAC's membership consists of 12 elected tribal officials representing each
17 Indian Health Service ("IHS") Area with each Area Director nominating two
18 members to represent the Area on NTAC, one nominee to serve as the primary
19 representative and the other as alternate; and

20 **WHEREAS,** in accordance with the NTAC's Charter, nominees must be elected tribal leaders
21 or be selected by tribal leaders; and

22 **WHEREAS,** by Resolution No. 15-281, Legislative Council Representative Arthur Wilson was
23 appointed to serve as the Nation's primary NTAC Area representative and
24 Representative Anthony J. Francisco, Jr., as his alternate; and

25 **WHEREAS,** Resolution No. 15-281 also provided that an appointment immediately expires
26 when the representative no longer serves on the Health and Human Services
27 Committee; and

28 **WHEREAS,** Representative Arthur Wilson no longer serves as a member of the Health and
29 Human Services Committee, which is the standing committee with primary
30 oversight jurisdiction over health-related matters; and

31 **WHEREAS,** the Health and Human Services Committee recommends nominating
32 Representative Adrienne Tiller as the primary NTAC Tucson Area representative

3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**
4 **Representative Adrienne Tiller as the primary NTAC Area representative and**
5 **Representative Anthony J. Francisco, Jr. as alternate to Representative Adrienne**
6 **Tiller.**

7 **BE IT FINALLY RESOLVED that any subsequent appointments made pursuant to this resolution**
8 **shall supersede any prior appointments to NTAC and shall immediately expire if**
9 **the appointed representatives no longer serve on the Health and Human Services**
10 **Committee for any reason.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
12 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
13 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
14 **Article VI, Section 1(b), Section 1(c)(2) and Section 1(j) of the Constitution of the Tohono**
15 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**
16 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
17 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




