

**RESOLUTION OF THE TOHONO O’ODHAM LEGISLATIVE COUNCIL
(Appointment of Representative Anthony J. Francisco, Jr. as Representative to
the Substance Abuse and Mental Health Services Administration Tribal Technical
Advisory Committee and Representative Adrienne Tiller as Alternate)**

RESOLUTION NO. 17-306

1 **WHEREAS, the Tohono O’odham Legislative Council is vested with the power “to promote,**
2 **protect and provide for public health . . . and general welfare of the Tohono**
3 **O’odham Nation and its members” and with the authority “to consult with the**
4 **Congress of the United States and appropriate federal agencies regarding federal**
5 **activities that affect the Tohono O’odham Nation” (Constitution, Article VI,**
6 **Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, in 1992 the Congress established the Substance Abuse and Mental Health Services**
8 **Administration (“SAMHSA”) as an agency within the U.S. Department of Health**
9 **and Human Services to reduce the impact of substance abuse and mental illness**
10 **on America’s communities; and**

11 **WHEREAS, SAMHSA established the SAMHSA Tribal Technical Advisory Committee (“SAMHSA**
12 **TTAC”) to serve as an advisory body to SAMHSA pursuant to Presidential Executive**
13 **Order No. 13175 and the November 9, 2009 Presidential Memorandum; and**

14 **WHEREAS, the SAMHSA TTAC is comprised of 14 elected tribal leaders and designated**
15 **alternates selected by their respective tribes to represent each of the 12 Indian**
16 **Health Service Area Offices and whose terms shall “coincide with each member’s**
17 **elected leadership term” (SAMHSA National Advisory Council Charter); and**

18 **WHEREAS, Representative Arthur Wilson was appointed as the Nation’s SAMHSA TTAC**
19 **Tucson Area representative and Representative Anthony J. Francisco, Jr. was**
20 **appointed as his alternate (Resolution No. 15-280); and**

21 **WHEREAS, Representative Arthur Wilson no longer serves on the Health and Human Services**
22 **Committee; and**

23 **WHEREAS, the Health and Human Services Committee recommends appointing**
24 **Representative Anthony J. Francisco, Jr. as Tucson Area representative on the**
25 **SAMHSA Tribal Technical Advisory Committee and Representative Adrienne**
26 **Tiller as alternate to Representative Anthony J. Francisco, Jr.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O’odham Legislative Council that it**
28 **appoints Representative Anthony J. Francisco, Jr. as Tucson Area representative**
29 **on the SAMHSA Tribal Technical Advisory Committee and Representative**
30 **Adrienne Tiller as alternate to Representative Anthony J. Francisco, Jr.**

31 **BE IT FINALLY RESOLVED by the Tohono O’odham Legislative Council that appointments made**
32 **pursuant to this resolution shall supersede any prior nominations and**
33 **appointments to the SAMHSA Tribal Technical Advisory Committee and shall**

immediately expire if the appointed representatives no longer serve on the Health and Human Services Committee for any reason.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(c)(2) and 1(j) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
