

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Anthony J. Francisco, Jr. as the American Indian and
Alaska Native Health Research Advisory Council Tucson Area Representative and
Representative Daniel L.A. Preston, III as Alternate)

RESOLUTION NO. 17-307

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**
2 **protect and provide for public health . . . and general welfare of the Tohono**
3 **O'odham Nation and its members" and with the authority "to consult with the**
4 **Congress of the United States and appropriate federal agencies regarding federal**
5 **activities that affect the Tohono O'odham Nation" (Constitution, Article VI,**
6 **Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, the American Indian and Alaska Native Health Research Advisory Council**
8 **("HRAC") supports collaborative approaches between federal and tribal partners**
9 **to reduce health disparities that affect American Indian and Alaska Native**
10 **communities; and**

11 **WHEREAS, the HRAC works with tribal leaders to set priorities and make recommendations**
12 **to U.S. Department of Health and Human Services ("HHS") leadership that inform**
13 **effective Native health programs and policies; and**

14 **WHEREAS, HRAC is comprised of 16 delegates, who are elected or appointed tribal officials**
15 **representing each of the 12 Indian Health Service ("IHS") Areas, and four national**
16 **at-large tribal member positions; and**

17 **WHEREAS, by Resolution No. 15-277, Legislative Council Representative Anthony J.**
18 **Francisco, Jr. was appointed to serve as the Nation's Tucson area representative**
19 **and Representative Daniel L.A. Preston, III as alternate to Representative**
20 **Anthony J. Francisco, Jr.; and**

21 **WHEREAS, the Health and Human Services Committee recommends nominating**
22 **Representative Anthony J. Francisco, Jr. as the HRAC Tucson Area representative**
23 **and Representative Daniel L.A. Preston, III as alternate to Representative**
24 **Anthony J. Francisco, Jr.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**
26 **Representative Anthony J. Francisco, Jr. as the American Indian and Alaska Native**
27 **HRAC Tucson Area representative and Representative Daniel L.A. Preston, III as**
28 **alternate to Representative Anthony J. Francisco, Jr.**

29 **BE IT FINALLY RESOLVED that any subsequent appointments made pursuant to this resolution**
30 **shall supersede any prior nominations and appointments to the HRAC and shall**
31 **immediately expire if the appointed representatives no longer serve on the**
32 **Health and Human Services Committee for any reason.**


