

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Pisinemo District Mining Royalties Budget)**

RESOLUTION NO. 17-315

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation:**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 16-017,**
13 **"Approving FY 2016 Apportionment of Mining Royalties by Equal Distribution"**
14 **and Pisinemo District was allocated an amount of \$115,253.30; and**

15 **WHEREAS, by Pisinemo District Council Resolutions No. 17-P-22 and 17-P-23, the Pisinemo**
16 **District has prepared and submitted for review and approval district budgets**
17 **utilizing FY 2016 Mining Royalties carryovers (1) FY 2017 San Simon Community**
18 **Mining Royalties Budget in the amount of \$6,752.75, which is incorporated by**
19 **this reference, and (2) FY 2017 Santa Cruz Community Mining Royalties Budget**
20 **in the amount of \$7,394.80, which is incorporated by this reference; and**

21 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 San Simon**
22 **Community Mining Royalties Budget and FY 2017 Santa Cruz Community Mining**
23 **Royalties Budget and recommends approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves (1)**
25 **FY 2017 San Simon Community Mining Royalties Budget in the amount of**
26 **\$6,752.75 and (2) FY 2017 Santa Cruz Community Mining Royalties Budget in the**
27 **amount of \$7,394.80 utilizing FY 2016 Mining Royalties carryovers.**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2017 San**
29 **Simon Community Mining Royalties Budget and FY 2017 Santa Cruz Community**
30 **Mining Royalties Budget shall be managed and expended in accordance with**
31 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
32 **Nation's laws, provided that any amendments or modifications shall be**
33 **authorized under District Council resolution and submitted for prior approval**
34 **by the Tohono O'odham Legislative Council.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
2 day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
3 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
4 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
5 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
7 (48 Stat.984).
