

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 San Simon Community Budget Amendment No. 2)**

RESOLUTION NO. 17-316

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation:

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2017 Pisinemo District Budgets in the amount of \$2,178,486.42 was
13 authorized by Pisinemo District Council Resolution 16-P-27 and approved by
14 Tohono O'odham Legislative Council Resolution No. 16-462; and

15 **WHEREAS,** pursuant to Pisinemo District Council Resolution No. 17-P-20, the Pisinemo
16 District has prepared and submitted for review and approval its FY 2017 San
17 Simon Community Budget Amendment No. 2, which is incorporated by this
18 reference, and which (1) increases the budget by \$7,920.43 utilizing FY 2016
19 gaming revenues carryovers; (2) increases operational line items; (3) adds new
20 line item "650 Tuition fees and Registration" with justification as stated; and (4)
21 adds new language "fire" to line item "865 Emergency Assistance"; and

22 **WHEREAS,** the FY 2017 San Simon Community Budget Amendment No. 2 will increase the FY
23 2017 San Simon Community Budget by \$7,920.43 from \$24,500.00 to \$32,420.43
24 and will increase the FY 2017 Pisinemo District Budgets from \$2,191,463.18 to
25 \$2,199,383.61; and

26 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2017 San Simon
27 Community Budget Amendment No. 2 and recommends its approval.

28 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
29 FY 2017 San Simon Community Budget Amendment No. 2 which includes a
30 \$7,920.43 increase from \$24,500.00 to \$32,420.43 that shall be funded from FY
31 2016 gaming revenues carryovers, and which will increase the FY 2017 Pisinemo
32 District Budgets from \$2,191,463.18 to \$2,199,383.61.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2017 San
34 Simon Community Budget as amended shall be managed and expended in
35 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham

Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
