

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Tohono O'odham Nation Department of Health and Human Services Senior Services Program Title III B Transportation Budget, Title III C-1 Congregate Budget, Title III C-2 Home Delivered Meals Budget, Title III E Outreach Budget, LTC Ombudsman Budget, ITCA Title III Training Budget, Caregiver Information and Referral Budget, and Title III Caregiver HPR CDSMP Budget)

RESOLUTION NO. 17-317

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Senior Services Program has prepared and submitted for review and approval
8 its FY 2018 Title III B Transportation Budget in the amount of \$33,020.00, Title III
9 C-1 Congregate Budget in the amount of \$61,153.00, Title III C-2 Home Delivered
10 Meals Budget in the amount of \$25,716.00, Title III E Outreach Budget in the
11 amount of \$8,171.00, LTC Ombudsman Budget in the amount of \$10,000.00, ITCA
12 Title III Training Budget in the amount of \$8,871.00, Caregiver Information and
13 Referral Budget in the amount of \$4,000.00, and Title III Caregiver HPR CDSMP
14 Budget in the amount of \$1,000.00, which are incorporated by this reference to be
15 funded from Title III of the Older Americans Act through the Inter-Tribal Council
16 of Arizona; and

17 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
18 reviewed the FY 2018 Senior Services Program Title III B Transportation Budget,
19 Title III C-1 Congregate Budget, Title III C-2 Home Delivered Meals Budget, Title
20 III E Outreach Budget, LTC Ombudsman Budget, ITCA Title III Training Budget,
21 Caregiver Information and Referral Budget, and Title III Caregiver HPR CDSMP
22 Budget and recommend their approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
24 FY 2018 Senior Services Program Title III B Transportation Budget in the amount
25 of \$33,020.00, Title III C-1 Congregate Budget in the amount of \$61,153.00, Title III
26 C-2 Home Delivered Meals Budget in the amount of \$25,716.00, Title III E
27 Outreach Budget in the amount of \$8,171.00, LTC Ombudsman Budget in the
28 amount of \$10,000.00, ITCA Title III Training Budget in the amount of \$8,871.00,
29 Caregiver Information and Referral Budget in the amount of \$4,000.00, and Title
30 III Caregiver HPR CDSMP Budget in the amount of \$1,000.00 effective July 1, 2017,
31 which shall be funded by Title III of the Older Americans Act through the Inter-

Tribal Council of Arizona and authorizes the use of the Nation's resources pending reimbursement from the grantor.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation chairperson or any designated official is authorized to administer and expend the FY 2018 Senior Services Program Title III B Transportation Budget, Title III C-1 Congregate Budget, Title III C-2 Home Delivered Meals Budget, Title III E Outreach Budget, LTC Ombudsman Budget, ITCA Title III Training Budget, Caregiver Information and Referral Budget, and Title III Caregiver HPR CDSMP Budget, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
