

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2017 Department of Health and Human Services Tribal Child Welfare  
Budget Amendment No. 1)**

**RESOLUTION NO. 17-318**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(3)); and**

7 **WHEREAS, the FY 2017 Department of Health and Human Services Tribal Child Welfare**  
8 **Budget in the amount of \$5,972,840.00 was approved by Resolution No. 16-322;**  
9 **and**

10 **WHEREAS, the Child Welfare Division prepared and submitted for review and approval its**  
11 **FY 2017 Budget Amendment No. 1, which is incorporated by this reference,**  
12 **which will adjust operational and personnel line items and establishes new line**  
13 **item for 7500 Major Capital; and**

14 **WHEREAS, the FY 2017 Department of Health and Human Services Tribal Child Welfare**  
15 **Budget Amendment No. 1 will result in no net change to the FY 2017 Tribal Child**  
16 **Welfare Budget; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
18 **reviewed the FY 2017 Department of Health and Human Services Tribal Child**  
19 **Welfare Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2017 Department of Health and Human Services Tribal Child Welfare Budget**  
22 **Amendment No. 1 which establishes new line item 7500 Major Capital.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
24 **O'odham Chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2017 Department of Health and Human Services Tribal Child**  
26 **Welfare Budget as amended, provided that further amendments or**  
27 **modifications shall be submitted to the Tohono O'odham Legislative Council for**  
28 **prior approval**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
30 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
35 **June 18, 1934 (48 Stat.984).**






