

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Department of Health and Human Services BIA Family
Preservation Budget Amendment No. 1)**

RESOLUTION NO. 17-319

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2017 Department of Health and Human Services ("DHHS") BIA Family**
8 **Preservation Budget in the total amount of \$317,560.00 was approved by**
9 **Resolution No. 16-326; and**

10 **WHEREAS, the DHHS Family Preservation prepared and submitted for review and approval**
11 **its FY 2017 Budget Amendment No. 1, which is incorporated by this reference,**
12 **and which will adjust personnel and operational line items and create new line**
13 **item 7400--RM Equipment; and**

14 **WHEREAS, the FY 2017 DHHS BIA Family Preservation Budget Amendment No. 1, will**
15 **increase the FY 2017 DHHS BIA Family Preservation Budget by \$240,876.57 from**
16 **\$317,560.00 to \$558,436.57; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2017 DHHS BIA Family Preservation Budget Amendment No. 1**
19 **and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 DHHS BIA Family Preservation Budget Amendment No. 1, effective**
22 **October 1, 2016, which includes a \$240,876.57 increase from \$317,560.00 to**
23 **\$558,436.57 that shall be funded with prior years savings from the DHHS BIA**
24 **Family Preservation Budget.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
26 **O'odham Chairperson or any designated official is authorized to administer and**
27 **expend the FY 2017 DHHS BIA Family Preservation Budget as amended, provided**
28 **that further amendments or modifications shall be submitted to the Tohono**
29 **O'odham Legislative Council for prior approval.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
31 **day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
36 **June 18, 1934 (48 Stat.984).**


