

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Education Department Child Care Services Program Child
Care and Development Fund Carry Forward Budgets)**

RESOLUTION NO. 17-327

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, on August 31, 2016, the United States Department of Health and Human Services**
8 **Administration for Children & Families awarded the Education Department a**
9 **grant in the amount of \$1,337,260.00 for a two-year project period ending**
10 **September 30, 2017; and**

11 **WHEREAS, the Education Department Child Care Services Program has prepared and**
12 **submitted for review and approval its FY 2017 Education Department Child Care**
13 **Services Program Child Care and Development Carry Forward Budgets, which are**
14 **incorporated by this reference, in the amount of \$575,496.00 that shall be funded**
15 **via reimbursement from the Grantor; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
17 **reviewed the FY 2017 Education Department Child Care Services Program Child**
18 **Care and Development Fund Carry Forward Budgets and recommend their**
19 **approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2017 Education Department Child Care Services Program Child Care and**
22 **Development Fund Discretionary Carry Forward Budget in the amount of**
23 **\$378,486.00 and the FY 2017 Education Department Child Care Services Program**
24 **Child Care and Development Fund Mandatory Carry Forward Budget in the**
25 **amount of \$197,010.00, for a total amount of \$575,496.00 which shall be funded**
26 **via reimbursement from the Grantor.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2017 Education Department Child Care Services Program Child**
30 **Care and Development Fund Carry Forward Budgets, provided however, that any**
31 **amendments or modifications shall be submitted for further prior approval by**
32 **the Tohono O'odham Legislative Council.**
