

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2018 Department of Education Child Care Services Title XX Budget)**

**RESOLUTION NO. 17-328**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control to the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, Intergovernmental Agreement was approved by Resolution No. 17-264; and**

8 **WHEREAS, the Department of Education Child Care Services provides services to improve**  
9 **the availability, affordability, and quality of child care through funding provided**  
10 **by the Arizona Department of Economic Security ("AZDES") Planned Social**  
11 **Services Block Grant Title XX Program; and**

12 **WHEREAS, the AZDES and the Tohono O'odham Nation ("Nation") executed an**  
13 **intergovernmental agreement by which the Nation will receive an AZDES Planned**  
14 **Social Services Block Grant Title XX Program in the amount of \$99,612.00 to**  
15 **reimburse the Nation for its Title XX expenses for the period beginning July 1,**  
16 **2017 through June 30, 2018; and**

17 **WHEREAS, the Department of Education has prepared and submitted for review and**  
18 **approval its FY 2018 Department of Education Child Care Services Title XX**  
19 **Budget, which is incorporated by this reference, in the amount of \$99,612.00 that**  
20 **shall be funded via reimbursement from the Grantor; and**

21 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**  
22 **have reviewed the FY 2018 Department of Education Child Care Services Title XX**  
23 **Budget and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
25 **FY 2018 Department of Education Child Care Services Title XX Budget in the**  
26 **amount of \$99,612.00 that shall be funded via reimbursement from the Grantor.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
28 **Nation chairperson or any designated official is authorized to administer and**  
29 **expend the FY 2018 Department of Education Child Care Services Title XX Budget,**  
30 **provided that any amendments or modifications shall be submitted for prior**  
31 **approval by the Tohono O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
