

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2017 Department of Education Division of Early Childhood
Development Head Start Grant Budget Amendment No. 1)**

RESOLUTION NO. 17-329

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2017 Department of Education Division of Early Childhood Development**
8 **Head Start Grant Budget in the amount of \$1,421,166.00 was approved by**
9 **Resolution No. 16-339; and**

10 **WHEREAS, The Department of Education has been awarded a Cost-Of-Living Adjustment**
11 **grant increase to the American Indian Alaskan Native Head Start Grant in the**
12 **amount of \$31,288.00; and**

13 **WHEREAS, the Division of Early Childhood Development has prepared and submitted for**
14 **review and approval its FY 2017 Division of Early Childhood Development Head**
15 **Start Grant Budget Amendment No. 1, which is incorporated by this reference and**
16 **which will add new line items and adjust personnel and operational line items;**
17 **and**

18 **WHEREAS, the FY 2017 Division of Early Childhood Development Head Start Grant Budget**
19 **Amendment No. 1 will increase the Division of Early Childhood Development FY**
20 **2017 Head Start Grant Budget by \$31,288.00 from \$1,421,166.00 to \$1,452,454.00,**
21 **which reflects a grant increase; and**

22 **WHEREAS, the Human Resources Development and the Budget and Finance Committees**
23 **have reviewed the FY 2017 Department of Education Division of Early Childhood**
24 **Development Head Start Grant Budget Amendment No. 1 and recommend its**
25 **approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
27 **FY 2017 Department of Education Division of Early Childhood Development Head**
28 **Start Grant Budget Amendment No. 1, which includes an increase of \$31,288.00**
29 **from \$1,421,166.00 to \$1,452,454.00 that shall be funded via reimbursement from**
30 **the Grantor.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
32 **Nation chairperson or any designated official is authorized to administer and**
33 **expend the FY 2017 Department of Education Division of Early Childhood**
34 **Development Head Start Grant Budget as amended, provided however, that any**

amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of JULY, 2017 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
