

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Membership Services Enrollment Program
Bureau of Indian Affairs (BIA) Carry Forward Budget)

RESOLUTION NO. 18-007

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Membership Services Enrollment Program received from the**
8 **Bureau of Indian Affairs a one-time funding allocation in the amount of**
9 **\$48,880.08 by P.L. 93-638 Master Contract amendment/modification number**
10 **0081 ending September 30, 2017; and**

11 **WHEREAS, the Department of Membership Services Enrollment Program has prepared and**
12 **submitted for review and approval its FY 2018 BIA Carry Forward Budget, which**
13 **is incorporated by this reference, in the amount of \$20,960.95, which shall be**
14 **funded by the Bureau of Indian Affairs one-time 638 funding allocation; and**

15 **WHEREAS, the Rules and the Budget and Finance Committees of the Tohono O'odham**
16 **Legislative Council have reviewed the FY 2018 Department of Membership**
17 **Services Enrollment Program BIA Carry Forward Budget and recommend its**
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2018 Department of Membership Services Enrollment Program BIA Carry**
21 **Forward Budget in the amount of \$20,960.95, which shall be funded by the Bureau**
22 **of Indian Affairs one-time 638 funding allocation.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2018 Department of Membership Services Enrollment Program BIA**
26 **Carry Forward Budget, provided that any amendments or modifications shall be**
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
29 **day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
