

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Tohono O'odham Nation Department of Public Safety Fire  
Department Capital Project Budget)**

**RESOLUTION NO. 18-008**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that all**  
4 **expenditures of these funds shall be pursuant to appropriation or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Department of Public Safety has prepared and**  
8 **submitted for review and approval its FY 2018 Fire Department Capital Project**  
9 **Budget, which is incorporated by this reference, in the amount of \$2,847,254.66 to**  
10 **be funded by the Nation's general fund; and**


11 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
12 **2018 Tohono O'odham Nation Department of Public Safety Fire Department**  
13 **Capital Project Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
15 **FY 2018 Tohono O'odham Nation Department of Public Safety Fire Department**  
16 **Capital Project Budget effective October 1, 2017 in the amount of \$2,847,254.66,**  
17 **which shall be funded by the Nation's general fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
19 **Nation chairperson or any designated official is authorized to administer and**  
20 **expend the FY 2018 Tohono O'odham Nation Department of Public Safety Fire**  
21 **Department Capital Project Budget, provided however, that any amendments or**  
22 **modifications shall be submitted for prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
25 **day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat.984).**
