10		its FY 2018 Budget Amendment No. 1, which is incorporated by this reference and
11		which will provide funds to pay for the Nation's tribal membership dues for the
12		Native American Finance Officers Association ("NAFOA"); and
13	WHEREAS,	the FY 2018 Office of the Treasurer Budget Amendment No. 1 will increase the FY
14		2018 Office of Treasurer Budget by \$5,000.00 from \$832,950.90 to \$837,950.90; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2018 Office of the
16		Treasurer Budget Amendment No. 1 and recommends its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2018 Office of the Treasurer Budget Amendment No. 1 effective October 1, 2017,
19		which includes a \$5,000.00 increase from \$832,950.90 to \$837,950.90 that shall be
20		funded by general fund surplus.
