

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Department of Health and Human Services Division of Senior Services Title VI Budget Amendments No. 1)**

**RESOLUTION NO. 18-011**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Health and Human Services Division of Senior Services**  
8 **Title VI-C Caregiver Support Budget in the amount of \$57,120.00 and Title VI-A**  
9 **Grants for Native Americans Budget in the amount of \$184,510.00 were approved**  
10 **by Resolution No. 17-256; and**

11 **WHEREAS, the Department of Health and Human Services ("DHHS") has prepared and**  
12 **submitted for review and approval its FY 2018 Division of Senior Services Title VI**  
13 **Budget Amendments No. 1, which are incorporated by this reference and which**  
14 **will adjust operational and/or personnel line items; and**

15 **WHEREAS, the FY 2018 DHHS Division of Senior Services Title VI-C Caregiver Support Budget**  
16 **Amendment No. 1 will decrease the FY 2018 DHHS Senior Services Title VI-C**  
17 **Caregiver Support Budget by \$1,840.00 from \$57,120.00 to \$55,280.00; and**

18 **WHEREAS, the FY 2018 DHHS Division of Senior Services Title VI-A Grants for Native**  
19 **Americans Budget Amendment No. 1 will decrease the FY 2018 DHHS Senior**  
20 **Services Title VI-A Grants for Native Americans Budget by \$3,790.00 from**  
21 **\$184,510.00 to \$180,720.00; and**

22 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
23 **reviewed the FY 2018 DHHS Division of Senior Services Title VI Budget**  
24 **Amendments No. 1 and recommend their approval.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
26 **FY 2018 Department of Health and Human Services Division of Senior Services**  
27 **Title VI-C Caregiver Support Budget Amendment No. 1 effective April 1, 2017,**  
28 **which includes a \$1,840.00 decrease from \$57,120.00 to \$55,280.00, and FY 2018**  
29 **Department of Health and Human Services Division of Senior Services Title VI-A**  
30 **Grants for Native Americans Budget Amendment No. 1 effective April 1, 2017,**  
31 **which includes a \$3,790.00 decrease from \$184,510.00 to \$180,720.00.**

32 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
33 **Nation chairperson or any designated official is authorized to administer and**  
34 **expend the FY 2018 Department of Health and Human Services Division of Senior**  
35 **Services Title VI Budgets as amended, provided however, that any amendments**

or modifications shall be submitted to the Tohono O'odham Legislative Council for prior approval.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0- AGAINST; -0- NOT VOTING; and 232.3[07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
