

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Division of
Community Health Services Cancer Prevention Program Budget)

RESOLUTION NO. 18-012

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services Division of Community Health
8 Services has prepared and submitted for review and approval its FY 2018 Cancer
9 Prevention Program Budget, which is incorporated by this reference, in the
10 amount of \$56,443.00 to be funded from the Nation's general fund; and

11 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
12 reviewed the FY 2018 Department of Health and Human Services Division of
13 Community Health Services Cancer Prevention Program Budget and recommend
14 its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that that the Tohono O'odham Legislative Council approves
16 the FY 2018 Department of Health and Human Services Division of Community
17 Health Services Cancer Prevention Program Budget effective January 1, 2018 in
18 the amount of \$56,443.00, which shall be funded by the Nation's general fund.

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
20 Nation chairperson or any designated official is authorized to administer and
21 expend the FY 2018 Department of Health and Human Services Division of
22 Community Health Services Cancer Prevention Program Budget, provided that
23 any amendments or modifications shall be submitted for prior approval by the
24 Tohono O'odham Legislative Council.

25 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH
26 day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR;
27 -0- AGAINST; -0- NOT VOTING; and 232.3[07] ABSENT, pursuant to the powers vested in the
28 Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,
29 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
30 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
31 Act of June 18, 1934 (48 Stat.984).


