

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting U.S. Department of Health and Human Services Family Violence Prevention
and Services Act Grant and Approving FY 2018 Department of Health and Human
Services Family Violence Prevention Budget)**

RESOLUTION NO. 18-013

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services ("DHHS") submitted an
8 application for a U.S. Department of Health and Human Services Family Violence
9 Prevention and Services Act Grant to support emergency shelter and supportive
10 services for victims of domestic violence and their dependents; and

11 **WHEREAS,** the Tohono O'odham Nation received a Family Violence Prevention and Services
12 Act Grant award in the amount of \$73,305.00 for the period of October 1, 2017 to
13 September 30, 2018; and

14 **WHEREAS,** the DHHS has prepared and submitted for review and approval its FY 2018 Family
15 Violence Prevention Budget, which is incorporated by this reference, in the
16 amount of \$73,305.00 to be funded by the Nation's General Fund pending
17 reimbursement from the U.S. Department of Health and Human Services; and

18 **WHEREAS,** the Health and Human Services and Budget and Finance Committee have
19 reviewed the FY 2018 DHHS Family Violence Prevention Budget and recommend
20 its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the
22 U.S. Department of Health and Human Services, Family Violence Prevention and
23 Services Act Grant for \$73,305.00 and approve the FY 2018 DHHS Family Violence
24 Prevention Budget, effective October 1, 2017, in the amount of \$73,305.00 shall be
25 funded by the Nation's General Fund pending reimbursement from the U.S.
26 Department of Health and Human Services.

27 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council authorizes the Tohono
28 O'odham Nation chairperson or any designated official to administer and expend
29 the FY 2018 DHHS Family Violence Prevention Budget provided, however, that any
30 amendments or modifications shall be submitted to the Tohono O'odham
31 Legislative Council for prior approval.


