

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Behavioral
Health/Domestic Violence Program Budget)**

RESOLUTION NO. 18-014

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services ("DHHS") has prepared and
8 submitted for review and approval its FY 2018 Behavioral Health/Domestic
9 Violence Program Budget, which is incorporated by this reference, in the amount
10 of \$49,750.00 to be funded by reimbursement from the Indian Health Service; and

11 **WHEREAS,** the Health and Human Services and the Budget and Finance Committees have
12 reviewed the FY 2018 DHHS Behavioral Health/Domestic Violence Program
13 Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2018 DHHS Behavioral Health/Domestic Violence Program Budget effective
16 September 30, 2017 in the amount of 49,750.00, which shall be funded by
17 reimbursement from the Indian Health Service.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2018 DHHS Behavioral Health/Domestic Violence Program Budget,
21 provided that any amendments or modifications shall be submitted for prior
22 approval by the Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
24 **day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 232.3 [06] ABSENT, pursuant to the powers vested in the Council**
26 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**


