

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Baboquivari District Administration Budget Amendment No. 1)

RESOLUTION NO. 18-019

1 **WHEREAS,** pursuant to Article 1X, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or to other authorized officer and the chairman
10 or vice-chairman of the district council.

12 **WHEREAS,** the FY 2018 Baboquivari District Budget in the amount of \$3,255,026.67 was
13 authorized by Baboquivari District Council by Resolution No. 2017-B-64 and
14 approved by Legislative Council Resolution No. 17-419; and

15 **WHEREAS,** by Baboquivari District Council by Resolution No. 2017-B-100, the Baboquivari
16 District has authorized and submitted for review and approval its FY 2018
17 Administration Budget Amendment No. 1, which is incorporated by this
18 reference and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2018 Baboquivari District Administration Budget Amendment No. 1 will
20 not affect the Baboquivari District Administration's original Budget of
21 \$942,206.56 nor the overall total of \$3,255,026.67; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Baboquivari
23 District Administration Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council
25 approves the FY 2018 Baboquivari District Administration Budget Amendment
26 No. 1 , in the amount of \$942,206.56, which will not affect the overall total District
27 budget of \$3,255,026.67.

28 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2018
29 Baboquivari District Administration Budget as amendment shall be managed
30 and expended in accordance with Article IX, Section 7 of the Constitution of the
31 Tohono O'odham Nation and the Nation's laws, provided that any amendments
32 or modifications shall be authorized under District Council resolution and
33 submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day of JANUARY, 2018 at a meeting at which a quorum was present with a vote of 2,639.8 FOR;-0- AGAINST; -0- NOT VOTING; and 444.8 [09] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


