

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Baboquivari District Choulic Community Budget Amendment No. 1)**

RESOLUTION NO. 18-020

1 **WHEREAS,** pursuant to Article 1X, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or to other authorized officer and the
10 chairman or vice-chairman of the district council.

11 ; and

12 **WHEREAS,** the FY 2018 Baboquivari District in the amount of \$3,255,026.67 was authorized
13 by Baboquivari District Council Resolution No. 2017-B-64 and approved by
14 Legislative Council Resolution No. 17-419; and

15 **WHEREAS,** by Baboquivari District Council Resolution No. 2017-B-103, the Baboquivari
16 District has authorized and submitted for review and approval its FY 2018
17 Baboquivari District Choulic Community Budget Amendment No. 1, which is
18 incorporated by this reference and which will adjust operational and/or
19 personnel line items; and

20 **WHEREAS,** the FY 2018 Baboquivari District Choulic Community Budget Amendment No. 1
21 will not affect the overall amount of the Baboquivari District Budget nor will it
22 affect the original budget amount of \$355,233.10 for the Choulic Community;
23 and

24 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2018 Baboquivari
25 District Choulic Community Budget Amendment No. 1 and recommends its
26 approval.

27 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
28 FY 2018 Baboquivari District Choulic Community Budget Amendment No. 1,
29 which does not affect the original Choulic Community budget amount of
30 \$355,233.10, nor the overall Baboquivari District Budget in the amount of
31 \$3,255,026.67.

32 **BE IT FINALLY RESOLVED,** by the Tohono O'odham Legislative Council that the FY 2018
33 Baboquivari District Choulic Community Budget as amended shall be managed
34 and expended in accordance with Article IX, Section 7 of the Constitution of the
35 Tohono O'odham Nation and the Nation's laws, provided that any amendments

or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.




