**Tucson Area Representative and Representative Anthony J. Francisco, Jr. as Alternate)**

**RESOLUTION NO. 18-024**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to promote,**  
2 **protect and provide for public health . . . and general welfare of the Tohono**  
3 **O'odham Nation and its members" and with the authority "to consult with the**  
4 **Congress of the United States and appropriate federal agencies regarding**  
5 **federal activities that affect the Tohono O'odham Nation" (Constitution, Article**  
6 **VI, Section 1(c)(2) and Section 1(j)); and**

7 **WHEREAS, the Tribal Technical Advisory Group ("TTAG") was formed by federal law to**  
8 **provide advice and feedback to the Centers for Medicare and Medicaid Services**  
9 **("CMS") on policy and program issues affecting delivery of health services to**  
10 **American Indian and Alaska Native people served by CMS-funded programs; and**

11 **WHEREAS, TTAG's membership consists of elected tribal leaders and alternates nominated**  
12 **from each of the twelve Indian Health Service Areas, including the Tucson Area;**  
13 **and**

14 **WHEREAS, Legislative Council Representative Daniel L.A. Preston, III was appointed to**  
15 **serve as the TTAG Tucson Area representative and Representative Anthony J.**  
16 **Francsico, Jr. served as Representative Daniel L.A. Preston, III's alternate**  
17 **(Resolution No. 15-278); and**

18 **WHEREAS, the current appointments to TTAG expired on December 31, 2017; and**

19 **WHEREAS, the Health and Human Services Committee recommends nominating**  
20 **Representative Daniel L.A. Preston, III for appointment as the TTAG Tucson Area**  
21 **representative and Representative Anthony J. Francisco, Jr. as alternate to**  
22 **Representative Daniel L.A. Preston, III.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**  
24 **Representative Daniel L.A. Preston, III for appointment as the TTAG Tucson Area**  
25 **representative and Representative Anthony J. Francisco, Jr. as alternate to**  
26 **Representative Daniel L.A. Preston, III.**

27 **BE IT FINALLY RESOLVED that appointments made pursuant to this resolution shall supersede**  
28 **any prior appointments to the TTAG and shall immediately expire if the**  
29 **appointed representatives no longer serve on the Health and Human Services**  
30 **Committee for any reason.**
